### INSCRIPTION CANYON WATER COMPANY

Dear Inscription Canyon Water Company Customer,

On July 12, 2023, the Arizona Corporation Commission voted to approve a rate increase requested by Inscription Canyon Water Company. Per Decision No. 79037, the new rates are effective on August 1, 2023.

Under the recently approved base rates, the typical residential bill for a 5/8 x 3/4-inch meter, with a median usage of 4,039 gallons, would increase by \$1.10, or 3.51%, from \$31.36 to \$32.46. With the Rate Case Expense Surcharge of \$0.49 per customer, the typical residential bill for a 5/8 x 3/4-inch meter would increase to \$32.95, a total increase of \$1.59 or 5.07%.
